



Classification of Membership

Equity membership in the Club is an opportunity to belong to a private golf, tennis, fitness, swimming and social club. As a Member of an equity, member-owned club, each Equity Member has ownership interest in the Club and is entitled to vote on matters affecting the Club, including the election of the Board of Directors of the Club. The Club offers four categories of Equity Membership: Full Membership, Sports Membership, Tennis Membership and Social Membership. Each category of membership provides certain privileges to use the Club facilities.

The membership entitles the Member and his or her family to use the Club facilities in accordance with the membership category selected by the Member. A Member's immediate family shall include the Member's spouse and their unmarried children under the age of twenty-three, who live at home or attend school on a full-time basis. The Club reserves the right, from time to time, to limit the use of the golf and tennis facilities of the Club by the immediate family of a Member during peak periods of play.

Full Membership / Refundable and Non-refundable

Full Membership. Full Members are entitled to use all the golf, tennis, swimming, fitness and dining facilities of the Club. Full Members have a seven-day sign-up privilege to reserve golf tee times and tennis court times. Full Members are not required to pay green fees for their use of the golf and tennis facilities of the club, but are required to pay golf cart fees.

Sports Membership / Refundable and Non-refundable

Sports Membership. Sports Members are entitled to use all of the golf, tennis, swimming, fitness and dining facilities of the Club. Sports Members have a seven-day sign-up privilege to reserve tennis court times and three-day sign-up privilege to reserve golf tee times. Sports Members are not required to pay court fees, but are required to pay greens fees and golf cart fees for their use of the **golf facilities of the Club.**

Tennis Membership

Tennis Membership. Tennis Members are entitled to use all of the tennis, fitness, swimming, and dining facilities. Tennis members have a seven-day sign-up privilege to reserve tennis court times. Tennis members are not required to pay court fees.

Social Membership

Social Membership. Social Members are entitled to use all of the swimming, fitness and dining facilities of the Club.
